## Key information

### Objective:

The fund's investment objective is to provide current income, consistent with a short duration profile as described in the prospectus and with the preservation of capital.

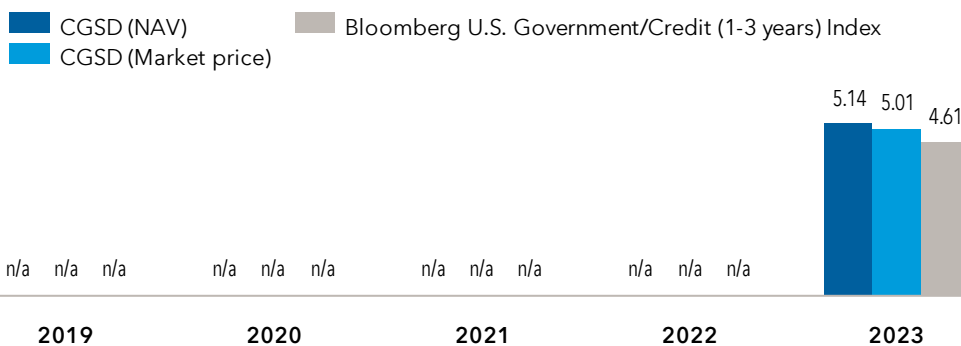
### Distinguishing characteristics:

Focused on current income while maintaining low interest rate exposure, this fund invests primarily in a high-quality mix of U.S. government bonds, corporate bonds, asset-backed and mortgage-backed securities. It seeks a higher income profile than enhanced cash investments with structurally less interest rate exposure than intermediate bond funds. Its flexible and research-driven approach is designed to produce a high-quality portfolio that is diversified across sectors and has the potential to offer attractive income while still preserving capital.

**Bond Statistic Average Yield to Worst:** Lower of Yield to Maturity or the bond's total return if put or call options are exercised prior to maturity but no default occurs. **Bond Statistic Effective Duration in Years:** Effective duration is a duration calculation for bonds that takes into account that expected cash flows will fluctuate as interest rates change. **Distribution Rate 12-Month:** The income per share paid by the fund over the past 12 months to an investor from dividends (including any special dividends). The distribution rate is expressed as a percentage of the current price. **Yield Annualized 30-Day SEC:** The 30-day SEC yield reflects the rate at which the fund is earning income on its current portfolio of securities calculated according to the standardized SEC formula; when applicable, it reflects the maximum sales charge. If shown, a net yield reflects fee waivers and/or expense reimbursements in effect during the period. Without waivers and/or reimbursements, the yield would be reduced. **Morningstar Category:** In an effort to classify funds by what they own, as well as by their prospectus objectives and styles, Morningstar developed Morningstar Categories. While the prospectus objective identifies a fund's investment goals based on the wording in the fund prospectus, the Morningstar Category identifies funds based on their actual investment styles as measured by their underlying portfolio holdings (portfolio and other statistics over the past three years). **Bloomberg U.S. Government|Credit (1-3 years) Index:** Bloomberg 1-3 Year U.S. Government|Credit Index is a market-value weighted index that tracks the total return results of fixed-rate, publicly placed, dollar-denominated obligations issued by the U.S. Treasury, U.S. government agencies, quasi-federal corporations, corporate or foreign debt guaranteed by the U.S. government, and U.S. corporate and foreign debentures and secured notes that meet specified maturity, liquidity and quality requirements, with maturities of one to three years.
