# **Key information**

## Objective:

To provide current income consistent with an ultra-short duration profile, focused on preservation of capital.

## Distinguishing characteristics:

Focused on current income while maintaining interest rate exposure under one year, this fund invests primarily in a high-quality mix of U.S. government bonds, short-term money market instruments such as commercial paper and certificates of deposit, corporate bonds and asset-backed securities of both U.S. and foreign issuers. It seeks a higher income profile than cash and money market funds with a duration of one year or less.
