Key information

Objective:

To provide current income consistent with an ultra-short duration profile, focused on preservation of capital.

Distinguishing characteristics:

Focused on current income while maintaining interest rate exposure under one year, this fund invests primarily in a high-quality mix of U.S. government bonds, short-term money market instruments such as commercial paper and certificates of deposit, corporate bonds and asset-backed securities of both U.S. and foreign issuers. It seeks a higher income profile than cash and money market funds with a duration of one year or less.

ICE BofA 3 Month US Treasury Bill Index: The ICE BofA 3 Month U.S. Treasury Index measures the performance of a single issue of outstanding treasury bill which matures closest to, but not beyond, three months from the rebalancing date. The issue is purchased at the beginning of the month and held for a full month; at the end of the month that issue is sold and rolled into a newly selected issue.
