Management's discussion of fund performance

The fund's Class R-2E shares gained 19.21% for the year ended October 31, 2024. That result compares with a 19.00% gain for the S&P Target Date 2020 Index. For information on returns for additional periods, including the fund lifetime, please refer to capitalgroup.com/mutual-fund-returns-R2E.

What factors influenced results

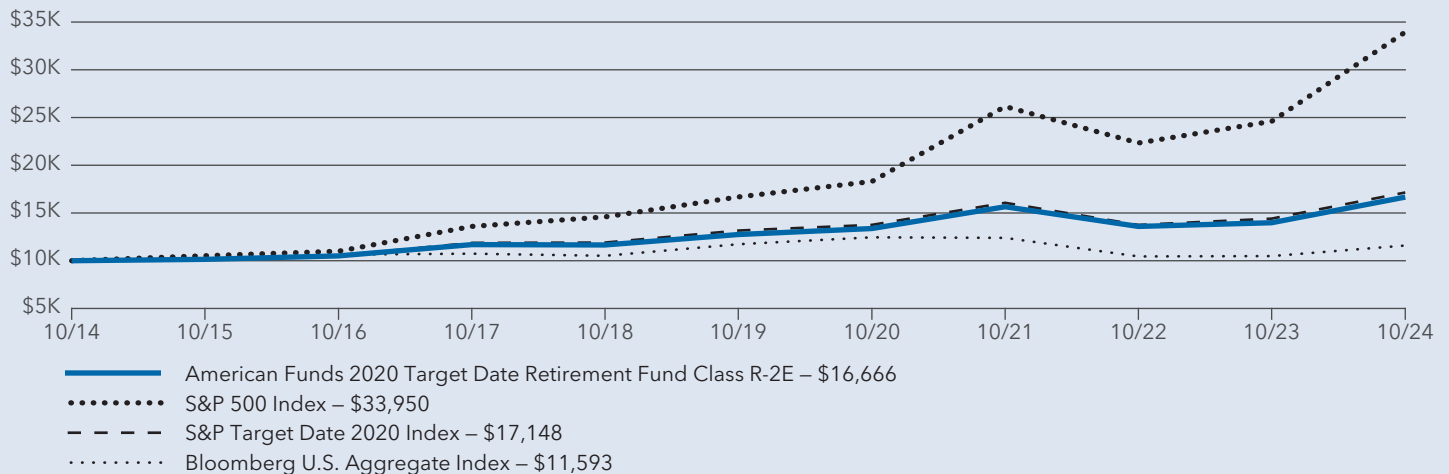
During the fund's fiscal year, the U.S. market showed resilience despite uncertainties. Strong consumer spending and a healthy labor market drove gross domestic product (GDP) growth while easing inflation, supported the U.S. Federal Reserve's rate cut. This initially pushed U.S. Treasury yields down, only to climb in October as concerns resurfaced about the long-term impact of rising U.S. debt.

Dividend-paying stocks were particularly additive to returns, and the portfolio's small holdings in growth-oriented equities also surpassed the overall portfolio returns. Equities domiciled in the United States were particularly additive to the portfolio's results.

Dividend-paying equities domiciled overseas, while offering positive returns, did not surpass those of the overall portfolio. And while the fund's bond holdings provided stability and income, their positive returns nonetheless were below those of the overall portfolio.

Effective July 24, 2024, the fund's primary benchmark changed from the S&P Target Date 2020 Index (the "Previous Primary Benchmark") to the S&P 500 Index, a broad-based index that represents the overall applicable securities market, as required by the SEC. The Previous Primary Benchmark provides a means to compare the fund's results to a benchmark that the investment adviser believes is more representative of the fund's investment allocations and objectives. There is no change in the fund's investment strategies as a result of the benchmark change.

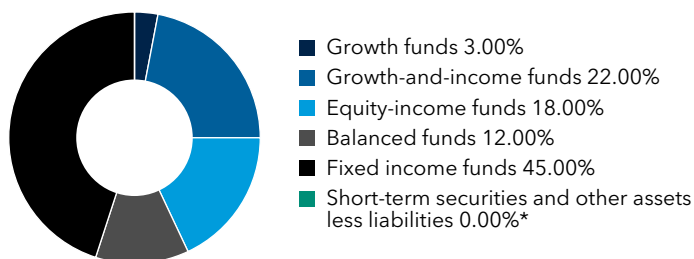
