# Management's discussion of fund performance

The fund's Class F-3 shares gained 23.57% for the year ended October 31, 2024. That result compares with a 22.37% gain for the S&P Target Date 2030 Index. For information on returns for additional periods, including the fund lifetime, please refer to **capitalgroup.com/mutual-fund-returns-F3**.

### What factors influenced results


The U.S. market was resilient despite uncertainties during the fund's fiscal year. Consumer strength and a healthy labor market drove gross domestic product (GDP) growth, while easing inflation supported the Federal Reserve's rate cut. This initially pushed U.S. Treasury yields down, only to climb in October as concerns resurfaced about the long-term impact of rising U.S. debt.

The fund's equity holdings in dividend-paying stocks, along with growth-oriented equities, surpassed the overall portfolio returns. Likewise, U.S.-domiciled equities strongly contributed to absolute returns.

Dividend-paying equities domiciled overseas, while offering positive returns, did not surpass those of the overall portfolio. While the fund's fixed income holdings had returns lower than those of the overall portfolio, the income and stability provided by bonds helped lower volatility during the fiscal year.

Effective July 24, 2024, the fund's primary benchmark changed from the S&P Target Date 2030 Index (the "Previous Primary Benchmark") to the S&P 500 Index, a broad-based index that represents the overall applicable securities market, as required by the SEC. The Previous Primary Benchmark provides a means to compare the fund's results to a benchmark that the investment adviser believes is more representative of the fund's investment allocations and objectives. There is no change in the fund's investment strategies as a result of the benchmark change.


