Management's discussion of fund performance

The fund's Class F-2 shares gained 29.39% for the year ended October 31, 2024. That result compares with a 27.29% gain for the S&P Target Date 2040 Index. For information on returns for additional periods, including the fund lifetime, please refer to capitalgroup.com/mutual-fund-returns-F2.

What factors influenced results

During the fund's fiscal year, the U.S. market showed resilience despite uncertainties. Strong consumer spending and a healthy labor market drove gross domestic product (GDP) growth while easing inflation, supported the U.S. Federal Reserve's rate cut. This initially pushed U.S. Treasury yields down, only for them to climb in October as concerns resurfaced about the long-term impact of rising U.S. debt.

Dividend-paying equities contributed greatly to the fund's return for the period, though growth-oriented equities were likewise additive. Equities domiciled in the U.S. were particularly additive to returns.

The fund's holdings in overseas equities saw returns somewhat below the fund's overall results. The fund's fixed income holdings, while posting positive returns, contributed less to the portfolio's total return, though they continue to offer opportunities for income and stability.


Effective July 24, 2024, the fund's primary benchmark changed from the S&P Target Date 2040 Index (the "Previous Primary Benchmark") to the S&P 500 Index, a broad-based index that represents the overall applicable securities market, as required by the SEC. The Previous Primary Benchmark provides a means to compare the fund's results to a benchmark that the investment adviser believes is more representative of the fund's investment allocations and objectives. There is no change in the fund's investment strategies as a result of the benchmark change.
