## Management's discussion of fund performance

The fund's Class R-3 shares gained 29.62% for the year ended October 31, 2024. That result compares with a 28.69% gain for the S&P Target Date 2045 Index. For information on returns for additional periods, including the fund lifetime, please refer to **capitalgroup.com/mutual-fund-returns-R3**.

## What factors influenced results


During the fund's fiscal year, the U.S. market showed resilience despite uncertainties. Strong consumer spending and a healthy labor market drove gross domestic product (GDP) growth while easing inflation, supported the U.S. Federal Reserve's rate cut. This initially pushed U.S. Treasury yields down, only for them to climb in October as concerns resurfaced about the long-term impact of rising U.S. debt.

Domestic equities were the primary driver of returns over the period, particularly among the portfolio's growth-oriented holdings. Certain dividend-payers and blue chip stocks also helped returns during the period.

The fund's holdings in overseas equities, while positive, were lesser contributors to the fund's overall return, as was the fund's fixedincome portfolio, though the latter does offer the opportunity for income and a degree of stability.

Effective July 24, 2024, the fund's primary benchmark changed from the S&PTarget Date 2045 Index (the "Previous Primary Benchmark") to the S&P 500 Index, a broad-based index that represents the overall applicable securities market, as required by the SEC. The Previous Primary Benchmark provides a means to compare the fund's results to a benchmark that the investment adviser believes is more representative of the fund's investment allocations and objectives. There is no change in the fund's investment strategies as a result of the benchmark change.
