### Objective:

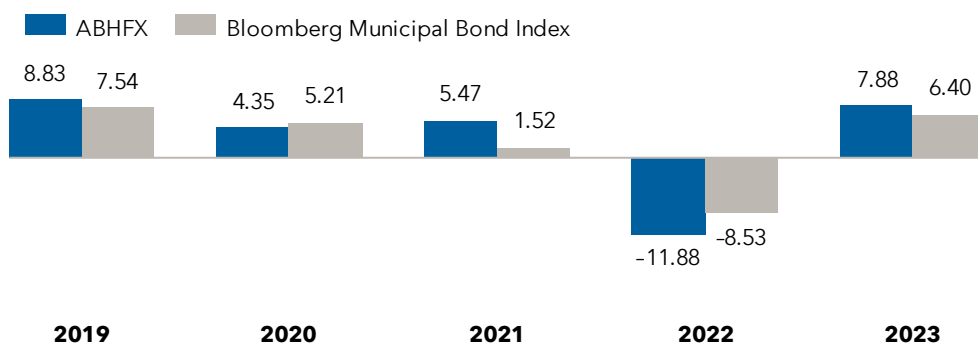
The fund's investment objective is to provide you with a high level of current income exempt from regular federal income tax.
