Distinguishing characteristics:

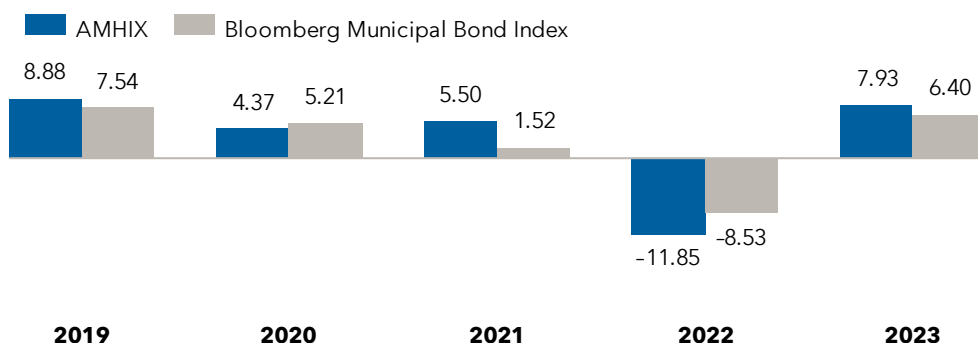
